

## **Privacy Policy**

Grindal Salmon Lodge wants to make your experience while using our services better. As part of this, we want you to feel safe and confident when using our websites. We understand that you want to know that your information is treated securely and that you need to know what kind of information that is collected through the use of our websites. We've created this document containing information about this to provide you information about this matter. By using our websites and services you indicate that you understand this and give your consent.

### **What information is collected?**

Information provided by user: When using our website, for example when you do things like search for products, register for an account or contact us via our online chat or contact form, some data are saved. This information is vital to give you a good experience and service.

### **3rd party login function**

If you should want to, we accept you to register and log into your account via 3rd party services, such as Facebook. By using this functionality, you also agree that we use the information about you from Facebook Connect to create your account.

### **Automatically collected information**

Like many websites, we collect information to understand our customers, so that we can provide a better experience and better security for both us and you as a user. Such information may be information about your browser version, IP-Address and screen resolution. We use this information to better understand "the big picture" and adjust our websites and services to best suit our users.

### **Cookie information**

One type of automatically collected information is in the form of "cookies". When using our website and services we might send one or more cookies to your computer or portable device. We use both session and permanent cookies to collect, store and sometimes track different information. A session-based cookie is one that delete itself when closing your browser. A permanent cookie will still be active after you close your browser (and can be used again next time you use our services). Permanent cookies can generally be removed by your browser. Refer to the help section of your browser to see how to remove cookies if you should want to do so.

### **How do Grindal Salmon Lodge use this information?**

We use this information that you have either given us, or we collected, to improve the user experience, and our services. We use the information to provide a service of good quality and to customize content to our users to give the best, and most relevant service for each user. This applies to content on our web pages, apps and marketing. The information is also uses for administrative work, and to keep in touch with our users.

### **How is this information shared?**

We may share your information with 3rd parties for their use in helping us perform our business functions.

We may also share some personal information if required by law, or whether it is necessary to protect our users security.

Should any part of Grindal Salmon Lodge be sold or in any way merged, we might share stored information with the new owner for the services to remain.

Our marketing technology may use cookies to present relevant offers and promotions to you through our marketing partners. This information can not be used to personally identify you, but is used for example to give you deals on products that are most relevant to you.
